The Truro Township Trustees held a regular and organizational meeting Thursday, January 8, 2026, at 4:00 pm at Station 161. Present were Administrator Jason Nicodemus, Trustees Dennis Nicodemus, Toni Kleckley and Pat Mahaffey, Fiscal Officer Natalie Nicodemus, and Chief Bryan.

The Meeting was called to order with the pledge and roll call.

Organizational Meeting

Toni Kleckley made a motion to nominate Pat Mahaffey to be Chairman of the Board of Trustees. There was no second on the motion.

Pat Mahaffey nominated Dennis Nicodemus to be Chairman of the Board of Trustees. Dennis Nicodemus seconded. Pat Mahaffey and Dennis Nicodemus voted yes. Toni Kleckley voted no.

Dennis Nicodemus nominated Pat Mahaffey to be Vice Chairman of the Board of Trustees. Pat Mahaffey seconded. Pat Mahaffey and Dennis Nicodemus voted yes. Toni Kleckley voted no.

Dennis Nicodemus made motion to establish regular monthly meetings at 4:00 p.m., first Thursday of each month at Township Fire Station #161, 6900 East Main Street. Dennis Nicodemus seconded. Pat Mahaffey and Dennis Nicodemus voted yes. Toni Kleckley voted no.

Dennis Nicodemus made a motion to authorize elected officials and department heads to attend national and state conferences. Pat Mahaffey seconded. All in favor.

Dennis Nicodemus made a motion to approve Trustees and Fiscal Officer to be paid by salary. Pat Mahaffey seconded. All in favor.

Regular Meeting

Received a quote for patching and painting of the interior of the Mausoleum. This is necessary due to water damage sustained prior to the new roof installation. The quote for \$58,000 will be presented to the Trustees for review.

Administration

Fiscal Officer's report: Approved December 2025 bank reconciliation.

Administrator Jason Nicodemus:

Year End preparations are still underway with financial reporting being processed by the end of January.

Presented quotes for copier leases as the current one is set to expire in March 2026. Quotes were obtained from Visual Edge IT and Modern Office Methods. We did not ask for a quote from the current provider, Comdoc/Xerox due to ongoing customer service issues. Jason's recommendation is to proceed with Modern Office Methods. Dennis Nicodemus made a motion to enter into a copier lease with Modern Office Methods. Pat Mahaffey seconded. All in favor.

Township has received speeding complaints on Quincy Drive. We are working with Franklin County to see what options there are to reduce speeding.



Truro Township was asked by the consumer council to join other Townships in opposition of the proposed rate increase with Aqua Ohio/PUCO. If we decide to join the opposition, we will need to pass a resolution at the February meeting. An increase is proposed at 17% water services and 30% water and sewer.

Dennis Nicodemus requested that Jason bring the resolution to oppose the increase to the February meeting and we would vote on it then.

Resolution 2025-20 was passed at the November meeting declaring the Ingersoll Rand R7.5i Fixed Speed 10 HP Rotary Screw Air Compressor as surplus. We would like to amend that resolution as the unit can be used by West Licking Fire by the mechanic that conducts preventive maintenance and repairs on our fleet. Dennis Nicodemus made a motion to not declare the Ingersoll Rand R7.5i Fixed Speed 10 HP Rotary Screw Air Compressor as surplus and donate it to West Licking Fire. Pat Mahaffey seconded. All in favor.

Trustee Reports

Toni Kleckley: Toni spoke about Ohio Township Day being February 1st and asked if we would be doing anything as a Township to celebrate. The Ohio Township Association has educational flyers available.

Pat Mahaffey and Dennis Nicodemus both welcome Trustee Toni Kleckley to the Truro Township. They also expressed gratitude to everyone involved in planning Tyler Norwood's funeral.

Pat Mahaffey: "I would like to say something about what it means to be a Trustee. You can see we have a lot of firefighters here tonight and we are responsible for their safety. Politics do not belong in this room. We run as non-partisans for a reason. So every motion we pass, every check we sign, every promotion we make, every new person we hire, has a direct effect not only on the safety of the firefighters but also the community at large. It is a very important thing. I think we witnessed how important it is when we lost a firefighter a couple of weeks ago. We not only had an outpouring from our community, but across central Ohio. And so, I take that responsibility very seriously. I always have since we have been here. I have mentioned before that it is hard sometimes to look at that stack of checks and feel comfortable in signing those things because when I first started, the firefighters asked me to run because there was a guy here that did not want to spend the money. And there was a check in there today that reminded me of it. It's \$63,000 for SCBA equipment and that was exactly the thing that he wouldn't sign the check for. He didn't feel like the Township should spend the money on that sort of thing. It would only take one firefighter having that equipment fail to die on the job and it's my responsibility to get levies passed, to approve budgets, and to

RESOLUTION NO. 2026-05

**Opposing Aqua Ohio's Request to Increase Water
and Sewer Rates and Requesting that the Public
Utilities Commission of Ohio Deny the Utilities Request**

WHEREAS, some of Truro Township's residents currently receive water and sewer service from Aqua Ohio; and

WHEREAS, Aqua Ohio has filed with the Public Utilities Commission of Ohio, in Case Nos. 25-0594-WW-AIR and 25-0593-ST-Air, et al, a request to increase the rates for water and sewer service rates provided to consumers, including the residents of Truro Township, Ohio; and

WHEREAS, Aqua Ohio's proposal, if adopted, will increase monthly utility charges to Truro Township, Ohio residents at a time when many residents are struggling with inflation and other proposed utility bill increases for electric and natural gas; and

WHEREAS, Truro Township, Ohio residents served by Aqua Ohio could be charged an additional \$11.94 per month for water service and \$16.86 per month for sewer service for a total proposed \$28.80 per month increase; and

WHEREAS, frequent increases in water and sewer rates negatively impact on our efforts to attract new businesses and jobs, act to depress the housing market and place an undue burden on all residents, including the elderly, and those living on fixed incomes.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Truro Township, County of Franklin, State of Ohio:

SECTION 1. That the Board of Trustees of Truro Township do hereby oppose Aqua Ohio's proposal to increase rates for water and sewer services to Truro Township, Ohio residents and request that the Public Utilities Commission of Ohio deny such rate increase to consumers.

SECTION 2. That the Board is hereby authorized and directed to forward a certified copy of this Resolution to the Public Utilities Commission of Ohio, Attn: Docketing Division

(Case Nos. 25-0594-WW-Air and 25-0593-ST-AIR), 180 E. broad Street, Columbus, Ohio 43215-3793.

SECTION 3. This Resolution shall be effective immediately or at the earliest date allowed by law.

SECTION 4. That the Township Fiscal Officer be and hereby is instructed to record this Resolution in the appropriate resolution book.

SECTION 5. That it is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
